As of January 17, 1975, the *Bundesanstalt für Bodenforschung*, Hanover, Germany, has been renamed *Bundesanstalt für Geowissenschaften und Rohstoffe* (BRG) (The Federal Institute for Geoscience and Natural Resources). The new name is "intended to emphasize that the Institute is competent in all fields of the geosciences and carries out essential geoscientific work related to mineral resources, energy resources, water and soil."

Summarizes 1974 mineral-industry data. Contains "information on the domestic industry structure, government programs, tariffs, and salient statistics for 95 individual minerals, metals, and fuels. World resource data appearing in the statements have been provided by the Geological Survey."

Computers & geosciences. Edited by Daniel F. Merriam. Oxford, Eng., Pergamon Press.

This new quarterly began publication in Spring 1975. The subscription price is \$60 per year. It will "serve as a public medium for exchange of ideas between the geological and computer sciences" and will contain computer programs, algorithms, computer-aided instructional material, programming guides and applications, and other topics of interest to geoscientists working with computers.

Contains 2,100 historic and new terms used throughout the petroleum industry, covering such major divisions as exploration, production, pipelining, refining, and petrochemical manufacture. Included are entries relating to offsea and subsea technologies, coal

gasification, and geographic-political considerations. The author, with 28 years experience in the industry and 10 years as editor of a major company magazine, has checked entries against authoritative sources, including oilmen in the field.
