# **BSI Prepares Standard For Map Citations**

In response to requests from map librarians and curators, the British Standards Institution is preparing a standard for map citations. BS 5195, Part I, has been issued under the title Recommendations for bibliographical references to maps and charts, Part I: References in accessions lists. Part II will be concerned with references in books and articles. The standard applies to single-sheet and multi-sheet maps, maps in series and maps in atlases. It notes both essential and supplementary descriptive terms for early and modern manuscript and printed maps. Examples of references which conform to the standard are given in an appendix. ### **National Geophysical Data Center Publishes Seismic Reflection Data**

## Minutes Geoscience Information Society 1977 Annual Business Meeting November 8, 1977 Seattle, Washington

The meeting was called to order by John Mulvihill at 9:15 a.m. The minutes of the 1976 meeting were read. Richard Walker requested that the minutes be changed so that his name be recorded as Richard and not Dick. The minutes were approved with the correction. Kay Keener presented the Treasurer's report for the period Jan. 1, 1977 - Oct. 31, 1977. The report was approved and filed for audit.

#### **OLD BUSINESS**

#### NOMINATING COMMITTEE REPORT Vivian Hall gave the report. The new officers are: Vice-President, President-elect, Julie Bichteler Secretary, Elizabeth Behrendt Treasurer-Robert Bier

Harriet Wallace asked why the ballots were late in being sent out. Vivian explained there were problems contacting the candidates and getting the ballots out on time. It was suggested that the committee be appointed earlier. Hart Phinney moved that the report of the nominating committee be accepted. Peg Marshburn seconded. The motion passed.

COMMITTEE ON INTERNATIONAL CONFERENCE Cornelius Burk gave the report for Dedy Ward. He presented a tentative program for the meeting. There was discussion of the objective of the meeting as stated on the program. The question was, should a recommendation come from the meeting? Ralph Farrar moved that at the international meeting we discuss the establishment of an international organization. The motion was seconded. Cornelius Burk presented a substitute motion that the international conference in London discuss alternative mechanism for increasing and promoting international cooperation for geological documentation and that a consensus be developed. This was seconded. The substitute motion carried. The mechanism to report back to the membership will be the Newsletter of GIS.

# BYLAWS AND CONSTITUTION REVISION COMMITTEE

Ralph Farrar presented the report. A proposed new Constitution and Bylaws was passed out and the changes from the old Constitution were discussed. Membership present at the meeting made suggestions for changes and clarification. The committee will incorporate these into the proposed Constitution and Bylaws to be sent to the membership for approval by mail ballot. Richard Walker moved that we accept the new Constitution and Bylaws as amended, edit and submit them to the membership. Seconded by Hart Phinney. Motion carried.

#### DIRECTORY OF GEOSCIENCE INFORMATION SOURCES

John Price of the Science and Technology Division of the Library of Congress asked GIS to support Library of Congress' publication of a directory of information sources in the geosciences. Hart Phinney moved that the President write a letter to the Library of Congress supporting this proposal. The motion was seconded by Kay Keener. The motion passed.

#### MARGE WHEELER

Vivian Hall moved that GIS send a letter to Marge Wheeler expressing sympathy on the recent loss of her husband. The motion was seconded and passed.

#### **GUIDEBOOK COMMITTEE**

Harriet Wallace reported for the committee. The third edition of the union list was shipped to AGI, which has produced camera-ready copy. The copy was reviewed by Harriet and the final editing is being done by GeoRef. The committee had met with John Mulvihill to discuss the problem of the number of times a title should be listed for guidebooks (under one main society or under all societies involved). It was decided that this edition will be published as previous editions and the new committee will try to solve the problem for future editions. No publication date other than early 1978 has been set and no price has been set. However GIS members will receive a 15% discount. Bea Lukins is the chairperson of the new committee. Other committee members are Barb Chappell, Marie Dvorzak, Marguerite Walsh, and Carolyn Kidd.

# DIRECTORY OF GEOSCIENCE LIBRARIES COMMITTEE

Richard Walker reported that there has been no action during the past year. The Executive Committee recommended to the membership that a committee be appointed to study the question of a new edition of the *Directory of geoscience libraries*, the need for a GIS membership list, and an arrangement with AGI to produce them by computer. It was suggested that the membership list also include a roster of past officers and the history of GIS. The recommendation carried.

#### THESIS COMMITTEE

The Executive Committee recommended to the membership that a committee be appointed to look into the production of a compiled bibliography of geologic theses from 1967 through 1976 or the years available in the GeoRef data base. The recommendation carried.

# REPORT OF THE GIS LIAISON TO ASIS, JULIE BICHTELER

Julie resigned as the liaison. This past year at the meeting there was a poster session for each society involved in the Committee of Liaisons to ASIS. The poster presented GIS' purposes, history, publications, etc. ASIS would like the liaison to be a three year appointment. GIS paid Julie's expenses to the meeting this past year because of the poster session.

#### GIS MEMBERSHIP FOLDER

Copies of the new brochure were distributed to members present. It was discussed that GIS should have a booth at the next GSA meeting. Suggestions of to whom to distribute the membership brochure: Geoscience departments, state surveys, other societies. A membership committee is needed to handle the distribution. Also a committee is needed to plan a booth for the 1978 meeting.

#### **EXECUTIVE COMMITTEE MEETING**

It was discussed that it would be helpful if the Executive Committee could meet during the year. It was decided that there is not enough money for the Society to pay expenses to such a meeting. The committee members will try to meet if they should happen to be at the same meeting, as ALA or SLA.

#### PAID STAFF

There was discussion at the Executive Committee meeting that there is a need for more continuity and transmission of information and wisdom from the past to the present officers. The Executive Committee recommended to the membership that the President appoint an historian. Expenses to attend the GIS annual meeting and office expenses would be paid by GIS. The appointment will be for two years on a trial basis. The responsibilities would include establishing a calendar for the year and codifying past actions of the Society. The recommendations carried.

#### NEWSLETTER

There is a need to distribute the work load to find out about new publications of interest to the Society. These would be included in the *Newsletter*. Certain members could volunteer to scan selected publications for information relevant to GIS and send this information to the *Newsletter* editor. It was suggested that we try to get some information into the *Newsletter* about individual members, such as past and president officers. Also we should continue the profiles of various organizations represented in the Society.

#### 1978 MEETING

The Executive Committee recommended to the membership that the President appoint a hospitality committee to plan hospitality for the 1978 meeting and make recommendations for future meetings. (e.g., open house for new members, cocktail party). The recommendation carried.

#### **MINUTES**

The Executive Committee recommended to the membership that minutes of the business meeting of the annual meeting be published in the next issue of the *Newsletter* after the annual meeting. Committee reports, or summaries there of, would be included with the minutes. Any actions of the incoming Executive Committee at their first meeting should also be reported in the *Newsletter*. The recommendation carried.

#### JOB DESCRIPTIONS

The outgoing officers are writing job descriptions, manuals, and calendars for the incoming officers. These will be revised and passed on each year.

GIS AND AGI: AGI BOARD REPRESENTATIVE
The AGI Board Representative is to be appointed for
two years and should be a member of the Executive
Committee. This is the request of AGI. Richard Walker
moved that the Representative to the AGI Board be for a
two year term beginning in 1978 and be reappointed
every even number year. The motion was seconded by
Vivian Hall. The motion carried.

# **GSA BIBLIOGRAPHY COVERAGE STUDY**

The study is to compile a list of serials to be regularly and quickly covered and the countries to be covered so users will be able to know what to expect to find in the bibliography. The study is being conducted by GeoRef. Hart Phinney moved that GIS participate in this study. The motion was seconded and carried. A committee will be appointed to meet with a representative of GeoRef and then make recommendations to GIS. Richard Walker recommended that the two GIS members on the GeoRef Advisory Board serve as this committee.

#### **NEW BUSINESS**

#### **SPONSORS**

Hart Phinney reported that the Conants in Washington, D.C., wish to be relieved as sponsors of GIS in D.C., where GIS is incorporated. John Mulvihill will look into whether we have to reincorporate or whether we can find a new sponsor in D.C.

#### **AUDITORS**

Robert Bier and Eleanor Wilkens were appointed auditors

#### ARCHIVES VS. WORKING PAPERS OF GIS

The Executive Committee in 1972 and 1973 discussed mailing three boxes of Society records around the country from officer to officer. It was decided at that time to place the papers and records at the USGS Library in Reston, Va. These records are filed there in an organized system. In 1976 the membership voted to place Society archives at the University of Illinois Library Archives. Some material has been placed there. This divides the records into two locations. Richard Walker moved that GIS keep its archives at the University of Illinois and that the working papers of the Society be housed at some place of convenience to the Society, temporarily at the USGS Library in Reston, Va. The motion was seconded and carried.

#### CORRESPONDENCE

John Mulvihill read a letter from the Women in Geosciences Committee of AGI asking for more recognition of women in the society. He responded that there is no problem of lack of recognition of women in GIS. He also read a letter from American Geophysical Union asking us to join them in supporting the new copyright law and a copyright clearance center. Discussion followed; no action was taken. There was a letter from the AESE suggesting a joint meeting. This was passed on to the new Vice-president as a program suggestion.

#### OTHER BUSINESS

Richard Walker asked that all existing committees report to him that they exist. Members were asked to sign up for committees on which they would like to serve. He also thanked all who had helped during the year. Richard Walker made a motion that the meeting be adjourned. Seconded by Robert Bier. Motion carried.

"In the field of mineral economics, the Bureau monitors more than 200 periodicals from around the world, as well as monographs, annual reports, and

transactions of conferences. Material of interest includes literature on metallics and non-metallics; on energy (coal, hydrocarbons, uranium); on legislation, nationalizations, trade agreements and other political actions; on markets, mergers, divestitures, and other corporate actions; on discoveries, transactions, projects, and significant technical developments." Every issue provides concise abstracts of over 300 documents organized by category and "key-word-incontext" indexing. *Mineral economics abstracts* will provide copies of any abstracted document, in the original language, for a nominal charge. Translation services are also available.
