The World Bank is now making some of its Landsat and thematic maps available through International Mapping Unlimited (IMU), its U.S. map distribution agent. Countrywide Landsat maps exist for Nepal, Bhutan, and Bangladesh, as do mosaics for portions of India, Burma, and Peru. Each map sheet is \$10.00 plus postage and handling. National Park Service Releases Natural History Theme Studies

Fifty-two natural history theme studies of ecological and geological features in 33 natural regions have been completed for the Natural Landmarks Branch, National Park Service. The studies include all 50 states, Puerto Rico, the Virgin Islands, the Pacific Trust Territories, and cover natural regions ranging from the Arctic Lowland to the Gulf Coastal Plain and Chihuahuan Desert. Twenty-four of the studies are available without charge as long as the supply lasts. All but two of the 52 studies are available from the National Technical Information Service (NTIS), U.S. Dept. of Commerce. The paper copies range in price from \$11.50 to \$50.50 each; the microfiche version is generally \$4.50.
